A RESOLUTION: SETTING THE CY 2013 TOWN COUNCIL CALENDAR

WHEREAS, the Town Council traditionally meets in formal session at 7:30 p.m., on the second and fourth Tuesday in each month and sits as a “committee of the whole” convening at 7:30 p.m. on the Monday preceding the regular council meeting in the Council Chambers, 25 West Market Street; and

WHEREAS, the Town Council traditionally cancels a set of meetings in August to provide for summer break; and

WHEREAS, Council would like to have this summer break coincide with the Loudoun County Public School calendar’s summer break; and

WHEREAS, the Town Council traditionally cancels the second meetings of December to observe the Christmas holiday; and

WHEREAS, the Town of Leesburg will observe Federal holidays on May 27 and November 11, 2013; and

WHEREAS, these Federal holidays will conflict with the work sessions; and

WHEREAS, the set of meetings that would be scheduled for March 25-26, 2013 occur during Loudoun County Public Schools spring break.

THEREFORE, RESOLVED by Council of the Town of Leesburg in Virginia as follows:

SECTION I. The Town Council shall meet in formal session at 7:30 p.m., on the second and fourth Tuesday in each month and shall sit as a “committee of the whole” convening at 7:30 p.m., on Monday preceding the regular council meeting in the Council Chamber, 25 West
