A RESOLUTION: APPROVING A SUPPLEMENTAL APPROPRIATION OF \$300 TO THE FISCAL YEAR 2015 GENERAL FUND FROM A DONATION AWARDED TO THE POLICE DEPARTMENT FROM LOUDOUN FIRST RESPONDERS FOUNDATION, INC.

WHEREAS, the Leesburg Police Department conducts a Junior Police Camp which is a community outreach program each summer; and

WHEREAS, the Loudoun First Responders Foundation, Inc. has awarded a donation to the Leesburg Police Department in the amount of \$300 to provide support and assistance to community outreach programs conducted by the Leesburg Police Department.

THEREFORE RESOLVED, by the Council of the Town of Leesburg in Virginia as follows:

SECTION 1. The Fiscal Year 2015 General Fund Budget is hereby amended and an appropriation is made in the amount of \$300 for the fiscal year beginning July 1, 2014 and ending June 30, 2015.

SECTION II. The Police Department budget is amended in the amount of \$300 for the purchase of items for the 2015 Junior Police Camp.
